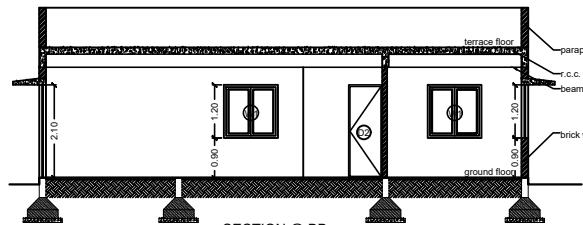

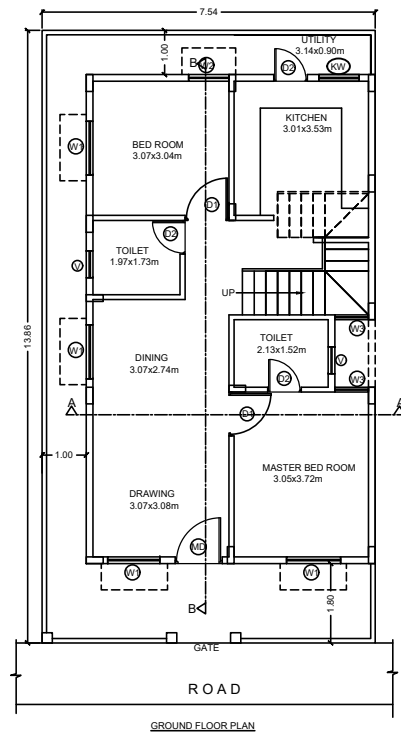

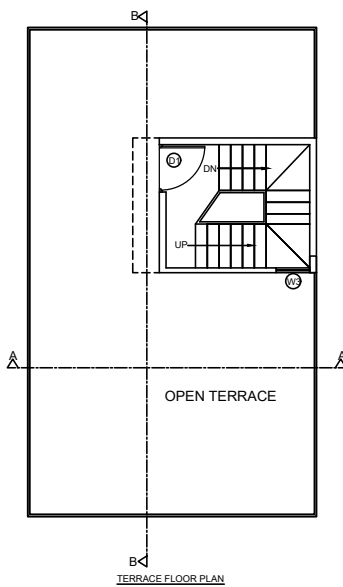

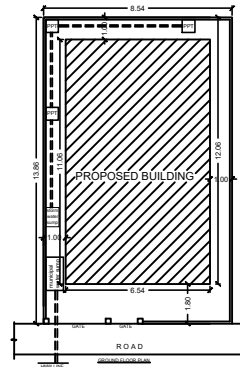
GROUND FLOOR PLAN



TERRACE FLOOR PLAN

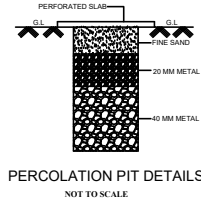

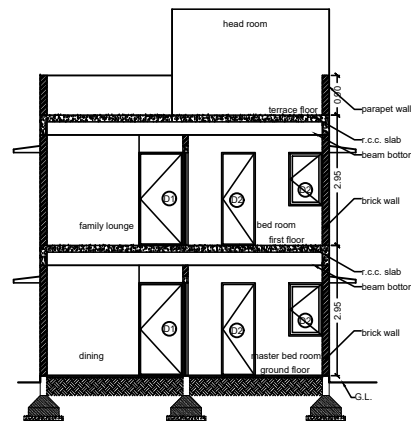

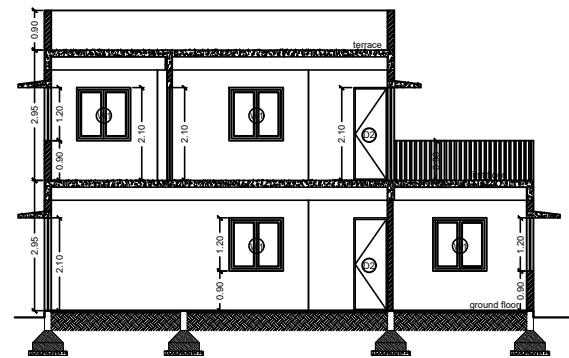
PERCOLATION PIT DETAILS

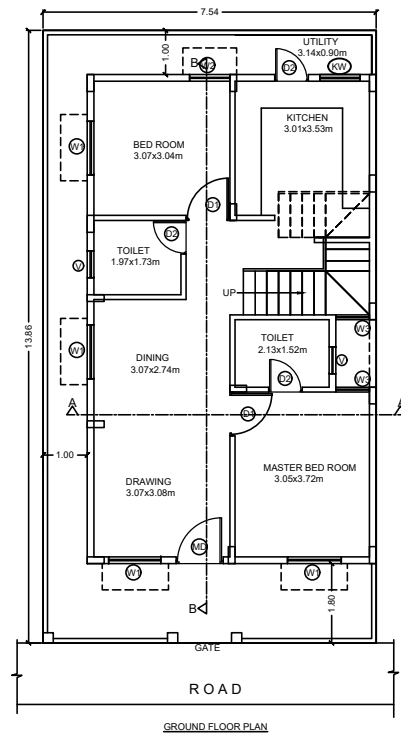

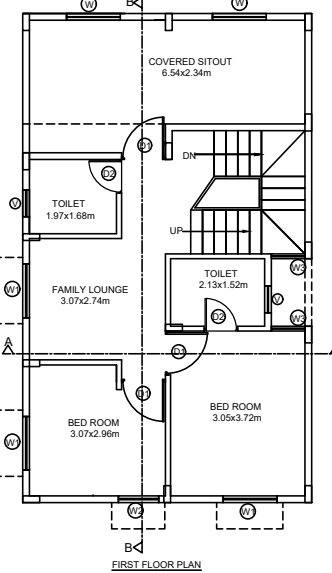

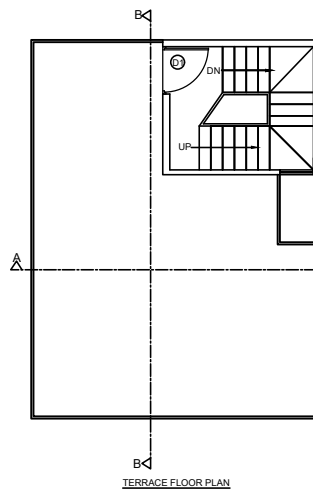

GROUND FLOOR PLAN



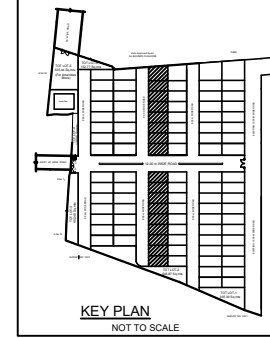
FIRST FLOOR PLAN
