5. Copy of any complaints or suggestions received in response to the said public notice(s) or otherwise.
6. Details and plans of other alternatives that may have been considered on an earlier date.
7. Please provide details as to whether the plan or alignment of the proposed FOB has been changed from any plan made on the earlier date. If so, provide details of reasons for such realignment.

You are requested to provide this information within 30 days of receiving this letter.

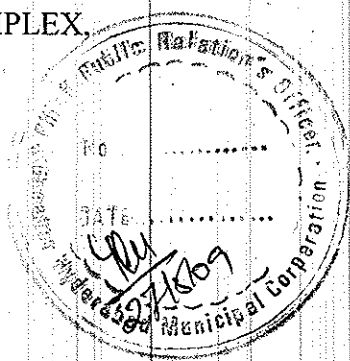
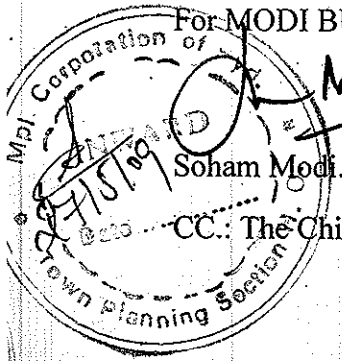
