3. In the year 2008 MCH revised the existing tax vide their Special Notice of House tax No. 236/E/ TC5/T5/2007 dated 31.01.2008 from Rs. 62,986/-(Half year tax) to Rs. 1,11,975/-(Half year tax). This tax revision was done as per the G. O. Ms. No. 635 MA&UD (TC-1) dated 27.08.2007 & G. O. Ms. No. 732 MA, MA & UD (T.C-1) dated 29.09.2007. As per the above said G. Os MCH is suppose to increase 50% of the existing yearly tax from 1st October 2007 onwards. 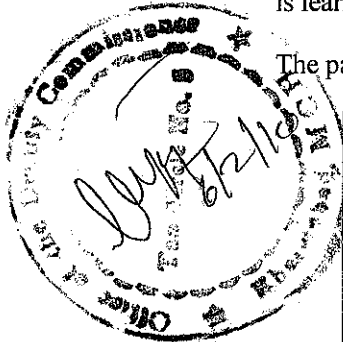

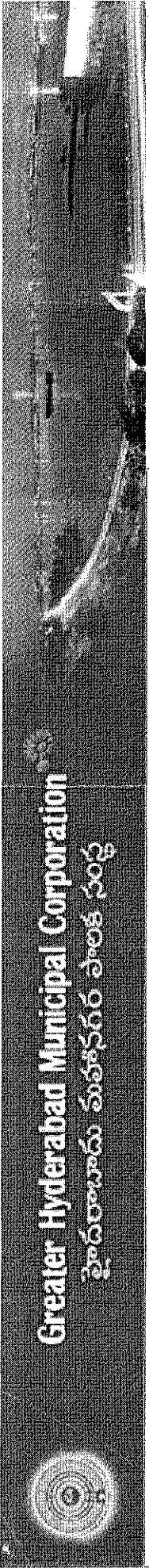
