## SUPPLEMENTARY AGREEMENT

This Supplementary Agreement is made and executed at Secunderabad on this the 21<sup>st</sup> day of Nov, 2012 by and between:

Satish Modi, aged 43 years, hereinafter referred to as the LESSEE (which term shall mean and include whenever the context may so require its successors-in-interest).

- A. Whereas the LESSEE has entered a Lease Agreement with the LESSOR on 8<sup>th</sup> July 2011 for about 3000 sq ft of the office space in the building known as Soham Mansion bearing No. 5-4-187/3 & 4, situated at Soham Mansion, M.G. Road, Secunderabad, on the terms and conditions contained therein.
- B. In the said lease agreement the LESSOR has restricted the LESSEE from subletting any portion of the leased premises. The LESSEE has requested the LESSOR to permit and allow its associate / subsidiary firms / companies to operate from the leased premises. The LESSOR has agreed to the LESSEE's request.

In continuation of the above referred Lease Agreement the LESSOR and the LESSEE hereby covenants as under.

- 1. The LESSEE shall be permitted to use and / or sub-let a portion of the premises admeasuring about 200 sft office space to M/s. MEHTA & MODI HOMES, a registered Partnership firm, as its office.
- 2. The LESSEE shall not be required to pay any additional rent to the LESSOR apart from the rent specified in the lease agreement dated 8<sup>th</sup> July 2011.
- 3. The other terms and conditions of Lease agreement dated 8<sup>th</sup> July 2011 shall continue to be inforce.
