The terms FIRST PARTY and SECOND PARTY shall mean and include all their heirs, successors-in-interest, assigns, legal representatives, executors etc.

WHEREAS:

- A) Late Shri Mogula Shankar Reddy, Late Shri Mogula Narayan Reddy and Late Shri Mogula Narsa Reddy were the original pattedars of agricultural land admeasuring about Ac. 16-09 Gts., in survey nos. 202 (Ac. 10-04 Gts.), 203 (Ac. 2-05 Gts.), 204 (Ac. 0-11 Gts.), 205 (Ac. 3-16 Gts.) & 206 (Ac. 0-13 Gts.), of Kowkur Village, Malkajgiri Mandal, Ranga Reddy District, Andhra Pradesh, hereinafter referred to as the Scheduled Land, more particularly described in the schedule given hereunder.

After the death of Late Shri M. Narayan Reddy his share of the Scheduled Land devolved to Shri M. Sudheer Reddy and Shri M. Sushanth Reddy being his sons and legal heirs. After the death of Late Shri M. Narsa Reddy his share of the Scheduled Land devolved to Shri M. Sai Reddy, Shri M. Sanjeev Reddy, Shri M. Srinivas Reddy and Shri M. Balwant Reddy being his sons and legal heirs.
- D) Accordingly, Shri M. Jagan Mohan Reddy, Shri M. Madhu Mohan Reddy, Shri M. Sudheer Reddy and Shri M. Sushanth Reddy (FIRST PARTY herein), Shri M. Sai Reddy, Shri M. Sanjeev Reddy, Shri M. Srinivas Reddy and Shri M. Balwant Reddy (SECOND PARTY herein), became the pattedars of the Scheduled Land and their names were mutated in the Revenue records. Pahanis for the year 1992-93 onwards reflect the name of above Pattedars. - G) Accordingly both the parties have amicably and mutually agreed to partition the Scheduled Land into two equal parts whereby the FIRST PARTY shall become the absolute owner of about Ac. 8-04 Gts., forming a part of survey nos. 202 (Ac. 1-39 Gts.), 203 (Ac. 2-05 Gts.), 204 (Ac. 0-11 Gts.), 205 (Ac. 3-16 Gts.) & 206 (Ac. 0-13 Gts.) of Kowkur Village and more particularly described in Scheduled A given hereunder (hereinafter referred to as the Schedule A Land) and the SECOND PARTY shall become the absolute owner of about Ac. 8-05 Gts., forming a part of survey nos. 202 (Ac. 8-05 Gts.) of Kowkur Village and more particularly described in Scheduled B given hereunder (hereinafter referred to as the Schedule B Land).
- H) The parties hereto are desirous of recording the understanding reached amongst themselves with regard to the partition of the Scheduled Land into writing.

 - b. The SECOND PARTY shall become the absolute owner of about Ac. 8-05 Gts., forming a part of survey nos. 202 (Ac. 8-05 Gts.) of Kowkur Village and more particularly described in Scheduled B given hereunder (hereinafter referred to as the Schedule B Land).

The parties hereto shall always indemnify and keep indemnified the other for any loss or damage caused on account the deeds and actions of each other.
