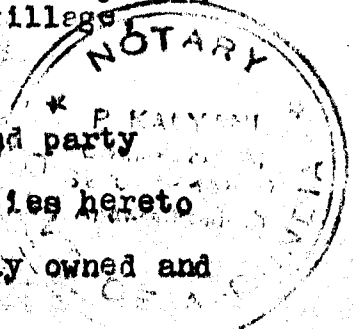

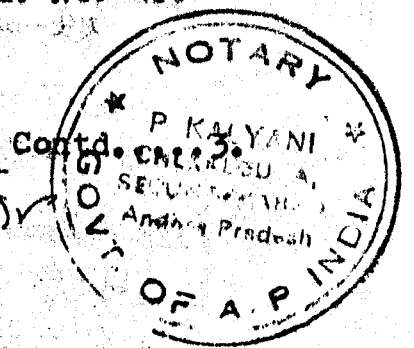

5. The parties have no claim against each other and they are entitled to get the patta mutated on the basis of this Memorandum of Partition.

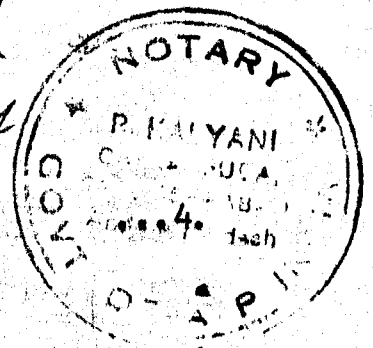
