Point of supply: Supply to be proposed loads will be extended as shown in the sketch.

Main Features: The proposal involves erection of the following.

- a) Erection of 1No.315 KVA DTR.
- b) Erection of 2No.RS Joist box poles.
- c) Laying of 11KV XLPE 95sqmm cable for a distance of 70mts.
- d) Laying of LT 31/2x185sqmm XLPE cable for a distance of 50mts.
- g) Effecting of 56Nos.3-Ph each 5KW domestic loads & 1No.3-Ph 20KW domestic loads over and above the existing 1No.3-Ph 5KW Non domestic load of Sc.No.2014-04859 making a total load of 305KW.
