We have enclosed herewith a gift settlement deed handing over internal roads and parks in the above said project in favour of Rampally Grampanchayat duly notarized..

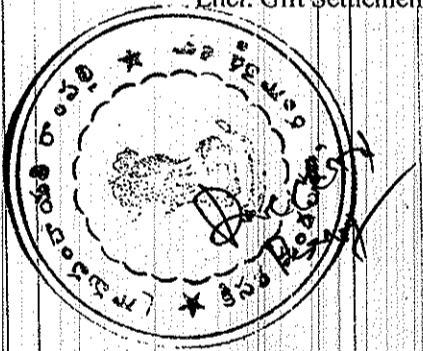
