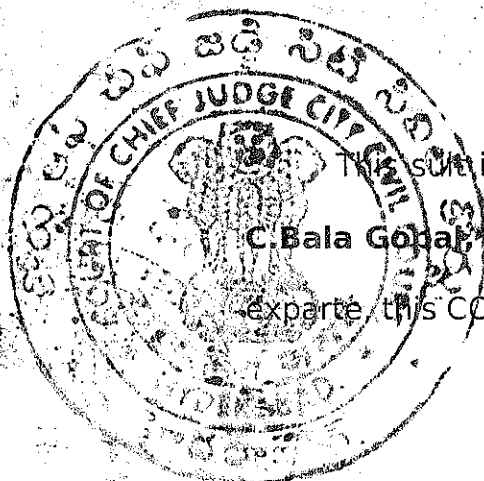

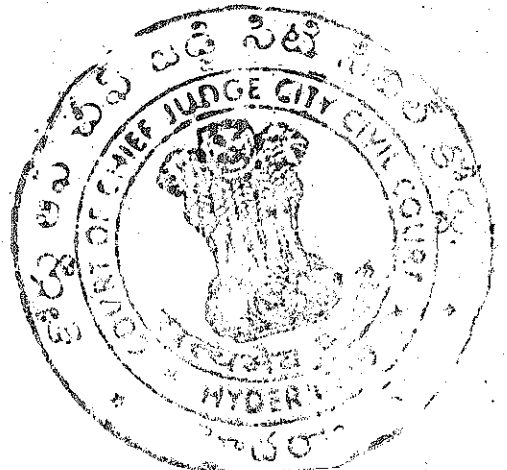

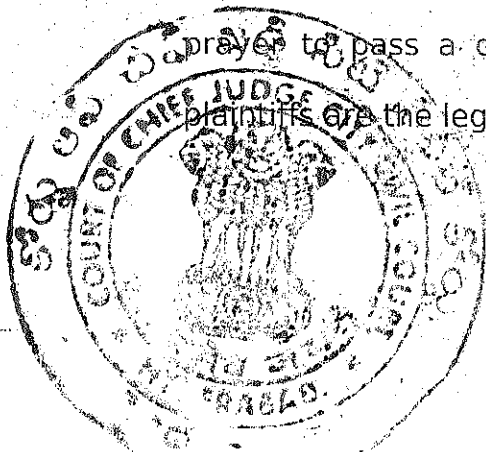

This suit is coming on this day before me for final hearing in the presence of **Sri C.Bala Gopal**, Counsel for the Plaintiff and defendant called absent and set exparte and the matter having stood over for consideration till this day, this court delivered the following.

J U D G M E N T

This is a suit filed Under Order VII Rule 1 R/W Section 26 C.P.C with a prayer to pass a decree in favour of the plaintiff to declare that the plaintiffs are the legal heirs of late Sri Syed Naseeruddin Siraj.

2. The brief averments of the plaint are as follows:

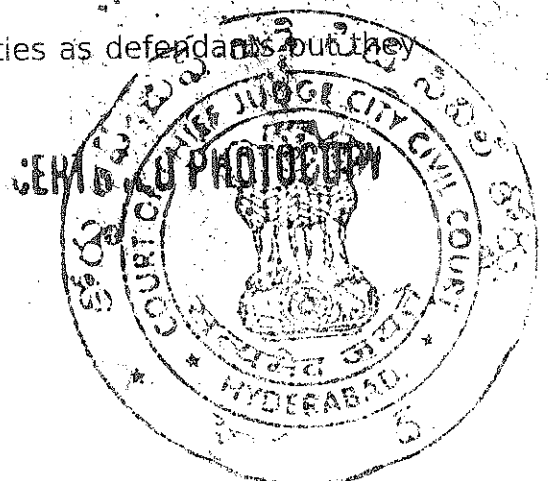
The plaintiff No.1 is the mother, plaintiff no.2 is the wife and plaintiff 3 and 4 are daughter and son of late Sri Syed Naseeruddin Siraj who died intestate on 10 4.2015 leaving behind the plaintiffs as legal heirs. After the death of late Sri Syed Naseeruddin Siraj, the plaintiffs approached the Tahasildhar, ^{Sherabad} Charminar Mandal for issue of legal heir certificate, but the same was refused and directed the plaintiffs to approach the Civil Court for issue of legal heir. Hence the plaintiffs are seeking declaration of their status as legal heirs of late Sri Syed Naseeruddin Siraj. Hence the present suit is filed.

3. After registering the suit paper publication was made for defendants but no objections received from the public therefore they were set exparte.

4. At the time of trial the plaintiff no.1 examined herself as PW1 and Ex.A1 to A3 marked. Ex.A1 is original death certificate of late Sri Syed Naseeruddin Siraj. Ex.A2 is original household card of plaintiffs 1 to 4. Ex.A3 is original Aadhar card of plaintiff no.1 to 4. It appears that the plaintiffs have chosen to file these documents to show that they are the legal heirs of late Sri Syed Naseeruddin Siraj.

5. Now the point for consideration whether the plaintiffs are entitled to the relief as prayed for?

6. The plaintiffs have filed this suit for declaring them as legal heirs of late Sri Sri Syed Naseeruddin Siraj. It is noticed that they have not approached any officials for issuance of legal heir certificate. It appears that the plaintiffs apprehension is that they have intestate the properties of the late Sri Syed Naseeruddin Siraj. In order to get the said lacuna they filed this suit. The plaintiffs have not made any parties as defendants but they




have mentioned the defendants The "Thasildhar" and "Ali Concern" and the publication was issued but no objection is received stating that the plaintiffs are not the legal heirs of late Sri Syed Naseeruddin Siraj.

7. The plaintiff no.1 is examined as PW1 stating that she is the mother of late Sri Syed Naseeruddin Siraj and plaintiff no.2 is wife of late Sri Syed Naseeruddin Siraj and plaintiff no.3 and 4 are daughter and son of late Sri Syed Naseeruddin Siraj. To substantiate their said version the PW1 has exhibited the proof of death of late Sri Syed Naseeruddin Siraj as Ex.A1. Ex.A2 is Original household card of plaintiff no.1 to 4. Ex.A4 are Aadhar cards of plaintiff no.1 to 4.

8. The unchallenged testimony of PW1 is sufficient to hold that the plaintiffs are the legal heirs of late Sri Syed Naseeruddin Siraj. Therefore the plaintiffs are entitled to the relief of declaring them as legal heirs of late Sri Syed Naseeruddin Siraj.

In the result, the suit of the plaintiffs is decreed without costs, declaring the plaintiffs no.1 to 4 as legal heirs of Late Sri Syed Naseeruddin Siraj.

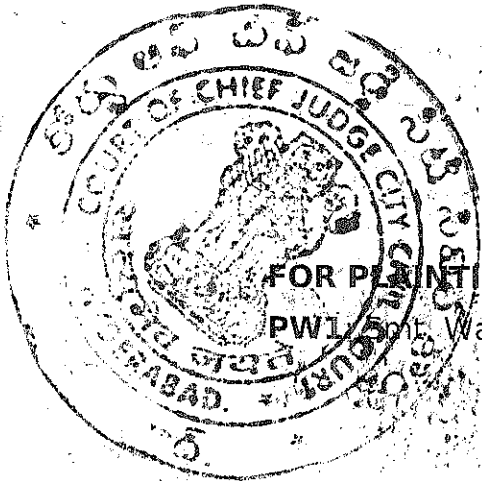
