Sub:- Mines and Quarries – Appeal filed by M/s. Alpine Estates against the Demand Notice No. 011/VG-CS/2008, dt. 15.07.2011 issued by the Asst. Director of Mines and Geology (Vg), Hyderabad - **Appeal disposed**– Orders - Issued.

ORDER:-

Through the reference 1st cited M/s. Alpine Estates preferred an appeal under Rule 35 of Andhra Pradesh Minor Mineral Concession Rules, 1966 against the demand notice No. 011/VG-CS/2008, dt. 15.07.2011 issued by the Asst. Director of Mines and Geology (Vg), Hyderabad. The appellant paid Rs: 500/- towards appeal fee vide challan No. 142918, dated: 11.08.2011.

The appellant in the grounds of appeal contested that they are undertaken the construction work and have the documentary proof of payment of Seigniorage fee for the consumed mineral but, due to unavoidable circumstances, could not place before the Authority before the issuance of Demand Notice. Therefore, requested to consider the documentary evidence and set-aside the Demand Notice issued by the Asst. Director of Mines and Geology (Vg), Hyderabad.

The Assistant Director of Mines and Geology(Vg), Hyderabad informed that the appellant failed to produce the documentary evidence within the stipulated time, hence, raised the demand.

A personal hearing of the appeal was conducted on 30.12.2015. The appellant and the Asst. Director of Mines and Geology (Vg), Hyderabad attended. After hearing the arguments and perusal of the record, directed the appellant to submit the documentary evidence in original before the Asst. Director of Mines and Geology(Vg), Hyderabad and directed the Asst. Director of Mines and Geology(Vg), Hyderabad to reconcile the entire evidence submitted as on date and issue fresh demand based on the reconciliation report, if necessary.

Further directed the ADM&G(Vg) Hyderabad to collect the demand amounts from the appellant as per the extension of one time settlement (OTS) order issued by the Government Vide G.O.RT No.255 Ind & comm. (Mines – I) Dept., dated 05.08.2015.

In view of the above and as per the powers delegated under Rule 35 of Andhra Pradesh Minor Mineral Concession Rules, 1966, the appeal filed by M/s. Alpine Estates is hereby **disposed** accordingly. The Deputy Director of Mines and Geology, Hyderabad and the Assistant Director of Mines and Geology (Vg), Hyderabad are directed to take necessary action in the matter as per rules.
