WIDTH OF ROADS:

The Proposed site has an approach raod on 40"-0" width road as main connecting road from main connecting -road, in the proposed lay out ,Gatted Community cum Group houses as 40"-0" main road & 30"-0" internal roads wide which satisfied GOMs.No. 62, MA dated 28.01.1970 and GOMs.No.528, MA date3d 25.09.1998. The total roads are is 8063.16 Sqmts (30.79%)

PLOT SIZE:

The Minimum plot House site size proposed is 217.8 Sqyd. & 173.75 Sqyd. Sqmt which is satisfies G.O.Ms.No.292 M.A dated 28.05.1994 of minimum plot size of 173.75 Syds.

RESERVED OPEN SPACE:
