The proponent obtained Environmental Clearance order dated 07.09.2012 as per the provisions of EIA Notification dt. 14.09.2006 for the construction project in the name and style of M/s. Vista Homes, Sy.Nos. 193, 194 & 195, Kapra (V), Keesara (M), Medchal-Malkajgiri District. Subsequently, the Proponent obtained Consent for Establishment Order dated 19.12.2012 from the Board for the project under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981.

As per the condition stipulated in the Consent for Establishment order, the project proponent shall submit half-yearly progress report on project implementation to the Regional Office of the Board. However, it was noticed that you have not submitted progress report on project implementation. As per the condition stipulated in the Consent for Establishment order, the project proponent shall obtain Consent for Operation of the Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 before commencing operations of the project. However, it is noticed that you have not yet obtained Consent for Operation of the Board.

In view of the above and keeping in view of the judgment dt. 25.01.2017 of the Hon'ble National Green Tribunal (NGT), Chennai in OA No. 106 of 2016 and directions dt. 03.03.2017 issued by the Central Pollution Control Board, this office issued Show Cause Notice to the proponent vide reference 6th cited.

The proponent submitted reply to the Notice vide reference 8th cited informing that the project does not require to obtain CFE and CFO of the Board as per CPCB letter dated 02.02.2017, MoEF&CC Notification No. SO 3999 dated 09.12.2016 and judgment dated 23.01.2012 of the Hon'ble High Court of Delhi in LPA 895/2010.

In this connection, it is to inform as follows:

- 1) The Ministry of Environment, Forest and Climate Change, Govt. of India earlier issued amendment of the EIA Notification, 2006 vide Notification S.O. No. 3999(E) dated 09.12.2016. In the amendment notification, it was stipulated that no Consent to Establish and Operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and control of pollution) Act, 1981 will be required from the State Pollution Control Boards for residential buildings up to 1,50,000 square meters.
- 2) Subsequently, the Society for Protection of Environment & Biodiversity, Gaziabad, Uttar Pradesh filed O.A. No. 677 of 2016 before the Hon'ble National Green Tribunal, Principal Bench, New Delhi praying the Hon'ble NGT to quash and set-aside the Notification dated 09.12.2016 issued by MoEF&CC.
- 3) The Hon'ble NGT issued judgment dated 08.12.2017 in O.A. No. 677 of 2016 and passed the following order/directions:
"
2. We hold and declare that (i) clause 14(8), (ii) the provisions relating to exclusion of Consent to Operate and Consent to Establish under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and control of pollution) Act, 1981 in clause 14 of the impugned Notification; (iii) Appendix-XVI relating to constitution and functioning of Environmental Cell, cannot be sustained and are liable to be quashed for the reasons aforesaid. Thus, we direct MoEF&CC to re-examine its Notification dated 9th December, 2016 and take appropriate steps to delete, amend and rectify the clauses of the said Notification in light of this judgement.
....."
- 4) The Ministry of Environment, Forest and Climate Change, Govt. of India issued OM dated 03.04.2018 for consideration of proposals for grant of ToR/EC to building construction projects.

In view of the above, you are once again directed to obtain Consent for Operation of the Telangana State Pollution Control Board as required under the provisions of Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 & amendments thereof immediately and report compliance to this office within Three days from the date of receipt of this letter, failing which action will be initiated against your project under section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and under section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981 without any further Notice.

You are also directed to note that operation of the project without obtaining consents of the Board is punishable under Section 44 of Water (Prevention and Control of Pollution) Act, 1974 and under Section 37 of Air (Prevention and Control of Pollution) Act, 1981 & amendments thereof.
