Vide reference 3rd cied, the RDO, Keesara Division has reported that the Joint Inspection has been conducted by Asst Executive Engineer IB Section Shamirpet, Tahsildar Shamirpet, Mandal Surveyor Shamirpet over the subject land reported that there is no water body in Sy Nos. 505, 506, 507, 508, 509, 510 & 511 admeasuring Ac: 6-18 ¾ gts situated at Kolthur Village, Shamirpet Village and the above land was in Down Stream Side of the Bund of Patel Kunta, Kolthur Village and one irrigation Chanal was passing through Sy. No. 506 for which FTL and boundary survey has been done and it was observed that the some part of the land in Sy. Further reported that the application has been got enquired by the Mandal Surveyor, which revealed out of Ac: 6-24 ¾ gts, the land to an extent of Ac: 0-02 gts., in Sy. No. 506 falls within the MFL, Ac: 0-02gts in Sy. No. 506 falls within Buffer Zone, Ac: 0-01 gts falls within MFL and Ac: 0-01gts., falls within Buffer Zone.
