We have submitted revised proposals for 8 (eight) blocks to construct residential apartments consisting two basements, ground + five upper floors in Sy. No. 19, Mallapur, GHMC Kapra Circle, Uppal Mandal, Medchal Malkazgiri District, Telangana and the same have been approved by GHMC building committee and asked us to pay a sum of Rs.3,86,67,660/- (Rupees Three Crores Eighty Seven Lakhs Sixty Seven Thousand Six Hundred and Sixty only) towards development, betterment and other charges and we have paid the above said fee/charges on 04<sup>th</sup> April 2019 and have requested GHMC to release sanction plans and proceedings.

We have submitted all required plans and documents to GHMC at the time of payment of fees.
