Mallapoor village of Hyderabad East Taluk filed a declaration under Section 8 of the Andhra Pradesh Land Reforms (Ceiling on Agricultural Holdings) Act, 1973 showing in Calmus Enclosure Wo.I of the declaration bearing 3, mos 119-29-107-120-111-129-129-131-132-137 to 141-143-165-116-176-186-187 measuring 85 acres 13 guntas situated at Mallapcor village of Hyderabad East Taluk, Hyderabad District and S.Nos.112-234-273-71-63 measuring 6 cores 22 guntas situated at Kistareddypet village of Sangareddy Taluk of Hedak District. In Enclosure Wo.II of the declaration he has shown that he is tenant og 8.80s 1103-104-105-169-171-172 to an extent of 10 acres 1 gunta situated at Mallapoor village of Hyderabad East Taluk. In Enclosure-I of the declaration he has stated that out of 85 acres 13 guntas of land at Hallapoor village and extent of 31 acres 19 guntas was acquired and sold.

The Spl.Dy.Tahsilder, Hyderabad kast Taluk has worked out the standard holding of S.Wo.29 measuring 1 acre 25 cents as 0.1756 standard holding and 65 S.Wo.111 measuring 4 acres 75 cents as 0.0723 standard holding which are incorrect but actually they work out to 0.0258 and 0.0753 standard holding respectively. After rectification the total standard holding for 98 acres 43 cents at Mallapoor village works out to 1.6686 standard holding.
