- Q) P. Rajaiah sold a portion of land admeasuring about Ac. 0-14 Gts., forming a part of Sy. - T) A portion of the Scheduled Land is proposed to be developed into a residential complex in parts. Accordingly, permit for construction on a portion of the Scheduled Land admeasuring Ac. 5-07½ Gts., was granted by HMDA in file no. 001839/MP2/Plg/HMDA /2013 dated 16.3.2015, permit no. 05/MP2/Plg/HMDA/2013 dated 16.03.2015. As per the said permit 79 villas and 35 flats are being developed on a portion of Scheduled Land along with amenities like roads, electric power supply, water supply, clubhouse, parks, etc.
- U) By virtue of the above documents, the Vendors have absolute rights to develop the Scheduled Land and it is absolutely entitled to sell villas along with plot of land and EWS / LIG flats.
- V) The proposed project of development on the entire Scheduled Land is styled as 'Nilgiri Estate'.
