ORDER:

Many representations have been received from various organizations to provide certain incentives to construction industry with a view to encourage the industry particularly the Housing Sector meant for Lower and Middle Classes.

2. Considering the representations received from various organizations and in order to encourage the Housing programs and constructions meant for Lower & Middle Classes, Government felt it necessary to provide certain incentives for Construction of Houses for lower and middle Class sections of the society and accordingly issued orders exempting the prescribed payment of Building Approval Fee / Building Permit Fee for a period of one year i.e. w.e.f 02.01.2009 to all Apartment complexes /Group housing projects on the built up area covered by a housing units of plinth area up to 1200 Sft (including common areas). In case, if only a part of the complex is proposed with Housing units of 1200 Sft, (including common areas) the said fee exemption shall be extended to that proportionate area only. The other fees and charges such as development charges, betterment charges etc., shall be levied as per existing norms. The said concession is applicable to the pending projects also, wherein applicants have not paid the building permit fees.

3. Now certain representations were received from various organizations and requested the Government to extend the above facility for a further period of two (2) years as the earlier orders issued by the Government have already expired.

4. Government, after careful examination of the matter and in order to encourage the Housing programs and constructions meant for Lower & Middle Classes, hereby exempt the concessions mentioned at para (2) above for a further period of two (2) years w.e.f 02.01.2010 subject to fulfilling of all other terms and conditions mentioned in the GO read above.
