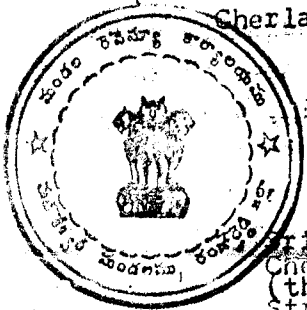

This is a petition filed under section 40 of Andhra Pradesh (T.A) Act 1950 for grant of succession in respect of lands bearing Sy.Nos.31 (2.5) 42(1.06) 61(0.17) 62(1.12) 64(0.38) 71(3.27) admeasuring Ac.9.25gts situated at Cherlapally village, Ghatkesar Mandal, Ranga Reddy District by Sri.P.Rajalinga Reddy 2.P.Narsimha Reddy 3.P.Janardhan Reddy 4.P.Jaganmohan Reddy and 5.P.Venugopal Reddy sons of late P.Krishna Reddy residents of Cherlapally village, Ghatkesar Mandal. In support of their claim they have filed a xerox copy of death certificate of Palle Krishna Reddy issued by Municipal Commissioner, Kapra Municipality dated 7.2.1992. a xerox copy of C.C. of P.T. Register and a certified copy of Patent for the year 1984-85. Notices have been issued to both the petitioners and Sri.Chinnama Raju Manikya Rao Partner of the lands in question from time to time and finally heard on 26.2.2000. A general notice to the public calling objections and public hearing in the village. No objections have been received so far. Heard on 18.5.92, 15.6.92, 18.7.92, 5.9.92, 27.9.95, 28.5.95, 23.9.95, 21.10.95, 27.2.99, 28.3.99, 3.7.99, 1.1.2000, 29.1.2000, 24.2.2000 and finally on 26.2.2000. On 26.2.2000 both the petitioners and respondents have filed Joint application wherein it is agreed to grant succession in favour of petitioners namely 1. P.Rajalinga Reddy 2. P.Narsimha Reddy 3. P.Janardhan Reddy 4. P.Jaganmohan Reddy and 5.P.Venugopal Reddy sons of Late Palle Krishna Reddy for the lands in Survey Numbers 31(2.05) 42 (1.06) 61 (0.17) 62 (1.12), 64 (0.38) 71 (3.27) admeasuring Ac.9.25 gts situated at Cherlapally village Ghatkesar Mandal and in turn the petitioners agreed to surrender their Protected Tenancy rights in Sy.No.61, 62, 64 and 71 admeasuring 0.17, 1.12, 0.38, and 3.27 respectively admeasuring Ac.6.14 gts situated at Cherlapally village in favour of the Legal Heirs of Ch.Manikyam namely 1. Ch.Murali 2. Ch.Jaihind 3. Ch.Venkateswar, 4 Ch.Padajiri 5. Ch. Prabhaker and 6. Ch.Srinivas. The Respondents also agreed to issue succession certificates in favour of petitioner U/s. 40 of A.P (TA) Tenancy & Agricultural Lands Act, 1950 and that they

have no objection in future and shall not claim any right. The Addl. Revenue Inspector, Ghatkesar Mandal has conducted local enquiry and submitted his report stating that the petitioners namely 1. P. Rajalinga Reddy 2. P. Narsimha Reddy 3. P. Janardhan Reddy 4. P. Jagannohan Reddy and P. Vax Venugopal Reddy are only the legal heirs of late P. Krishna Reddy and there are no other legal heirs other than the petitioners.

In view of the above facts stated above, succession is hereby granted to the petitioners namely 1. Palle Rajalinga Reddy 2. Palle Narsimha Reddy 3. Palle Janardhan Reddy 4. Palle Jagannohan Reddy and Palle Venugopal Reddy the sons of late P. Krishna Reddy of Cherlapally village under section 10 of A.P. (1A) Tenancy & Agricultural Lands Act, 1950 in respect of Sy. Nos. 31 (2.03), 42 (1.06), 61 (0.17), 62 (1.12), 64 (0.38), 71 (3.27) total extent Ac. 9.25 guntas situated at Cherlapally village, Ghatkesar Mandal, Ranga Reddy District.
