

#### **Brief Facts**

The above named plaintiffs humbly submit as under.

- 1. The above plaintiffs submit that the father of the plaintiffs Late Pentudu had three sons and two daughters namely E. Sathaiah, E. Sailu, E. Yadaiaha, Sukkama & Anjamma and the said Pentudu who hailed from Cherllapalli village Ghatakesar Mandal RR. District. The plaintiffs are the sons and daughters of the late Sri. Pentudu. The plaintiffs submit that the said Late Pentudu used to cultivate the land in the said village.
- 2. The plaintiffs further submit that the said Pentudu was doing agriculture as the protected tenant in old Sy No. 102 (New No 11,12,14 & 18) in Cherlla palli village, Ghatkesar Mandal R R. District. The Tahasildar Ghatkesar had entered the name of Late Pentudu as the protected tenant of the above said land and has issued a Certified copy of the same P.T records showing Late Pentudu as Protected Tenant.
- 3. The Plaintiff submits that the father of the plaintiff was the protected tenant in the suit scheduled property and was cultivating the land during his life time. The plaintiff submits that after the death of the their father the plaintiff never cultivated the land nor had been in position in the suit scheduled property.
- 4. The plaintiff further submits that on 26-03-08 the plaintiffs along with the land owners approached concerned Tahasildar and gave application to surrender the protected tenancy rights and to change in the Revenue rights but the said tahasildar refused to take the application and instead advice the plaintiff to get the declaration as legal heirs of the original Protect Tenant i.e., Pentudu from the Hon'ble Civil Court.
- 5. The plaintiffs further submit that the plaintiffs having no other alternative have approached this Hon'ble Court and filed the present suit for declaration to declare the plaintiffs as the legal heirs of Late Sri Pentudu.
- 6. The plaintiffs submit that Late Sri Pentudu died about 20 years back.
- 7. The plaintiffs submit that the cause of action to file the present suit arose when the plaintiffs approached the Tahasildar and requested the Tahasildar to surrender the Protected Tenancy Rights of the Late Sri Pentudu and when the Tahasildar directed the plaintiffs to approach the Hon'ble Civil Court for the said orders and on all such date and incidents as mentioned supra.






- 8. The plaintiffs submit that they have not filed any suit as regard the subject matter of this suit against the defendant herein before any Court of Law nor any suit as regards the subject matter of this suit is pending in any Court between the parties hereto.
