AFFIDAVIT

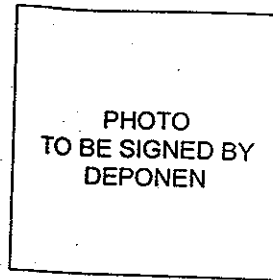
