SUBJECT: ISSUE OF NO OBJECTION CERTIFICATE: CASE No: 491/08/HY

- 1. Please refer to your letter No NiL dated received by this office on 25-08-08 on the subject stated above.
- 2. This office has no objection to the construction of the Proposed Commercial Complex by M/s Mehta & Modi Homes Rep. by Soham Modi and other Here in after referred to as the applicant at location On open land in Sy. No. 82/1,82/1.9 and Plot No. 15 & 20, Ward No. 3, Block No. 4 at Narsimha Nagar Colony, Mallapur, Village, Kapra Municipality, Uppal Manda, RR. Disti., A.P. (Co-ordinates 17° 26' 48" N 078° 34' 28" E) to a height of (in Fig) 75.0 Mts. (seventy five Decimal zero Nts.) ABOVE GROUND LEVEL, so that the top of the proposed structure when erected shall not exceed 528.0 Mts. AMSL*(site elevation) PLUS (+) 75.0 Mts. AGL (Height of the structure) = 603.0 Mts. AMSL. (six Hundred and three Decimal zero Mts.) ABOVE MEAN SEA LEVEL).
- 3. This No Objection Certificate is being issued on the express understanding that the site elevation reduced level (height above mean sea level 528.00 Mts AMSL relative location of the proposed building/structure and its distances and bearings from the ARP/runway ends, as tendered by the applicant(s) are correct. If, however, at any stage it is established that the said data as tendered by the said applicant is actually different from the one tendered and which could adversely affect aircraft operations, the structure or part(s) thereof in respect of which this 'No Objection Certificate' is being issued will have to be demolished at his own cost as may be directed by the Airports Authority of India. The applicant(s) is/are therefore advised in his/their own interest to verify the elevation and other data furnished for the site, before embarking on the proposed construction.
- 4. The issue of the 'No Objection Certificate' is further subject to the provisions of section 9-A of the Indian Aircraft Act, 1934, and those of any notifications issued there under from time to time and under which also the applicant may be called upon by the Airports Authority of India to demolish in whole or in part the structure now being authorized vide this 'No Objection Certificate'.
- 5. No Radio/TV Antenna, Lightening Arresters, Staircase, Mumtee, Overhead Water Tank and attachments of fixtures of any kind shall project above the height indicated in para 2.
- 6. The use of electric fired or oil fired furnace is obligatory, within 8 KM of the aerodrome.
- 7. This certificate is valid for a period of FIVE years from the date of its issue. If the building/structure/chimney is not constructed and completed within the above-mentioned period of FIVE years, he will be required to obtain fresh 'No Objection Certificate' from the G.M (ATM), Airports Authority of India, Hyderabad Airport, Hyderabad. The date of completion of building/structure/chimney should be intimated to the AAI and or GM (ATM), Hyderabad Airport, Hyderabad 500016. No light or a combination of lights which by reason of its intensity, configuration or color may cause confusion with the aeronautical ground lights of the airport shall be installed at the site at any time during or after the construction of the building.

Day & Night markings with secondary power supply may be provided as per ICAO standards.
