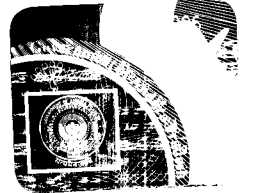

THIS DEED OF Reconveyance of Title Deeds is made and executed on this the 25th day of October, 2004 at Hyderabad by:-


