This DEED OF SALE is made and executed on this the 21 st day of June 1988, at Hyderabad, BY:

NOW THIS DEED OF SALE WITNESSETH AS FOLLOWS: That in pursuance of the above offer, acceptance and in consideration of Rs. 9.750/-(Ruees Nine thousand seven nundred fifty which amount has already been paid by the vendee to the vendors, the receipt of which sum the vendors hereby admit and acknowledge and further discharge the Vendee against any future liability of payment in this regard and the vendors as absolute owners of the schedule property do hereby transfer, convey and assign by way of ABSOLUTE SALE together with all the rights, privileges, liberties, easements, advantages and appurtenance pertaining thereto and the entire rights, title and interest which the vendors have in respect of the schedule property TO HAVE and TO HOLD the same to the Vendee as owner absolutely for ever;

The Vendors hereby declare and covenants with the Vendee as under:-

- 1. That the Vendors are the absolute owners of the property hereby conveyed and have full authority to convey the same;
- 2. The Vendors declare that the said property is not subject to any charges, mortgage or other encumbrances in favour of any other persons whatsoever;






