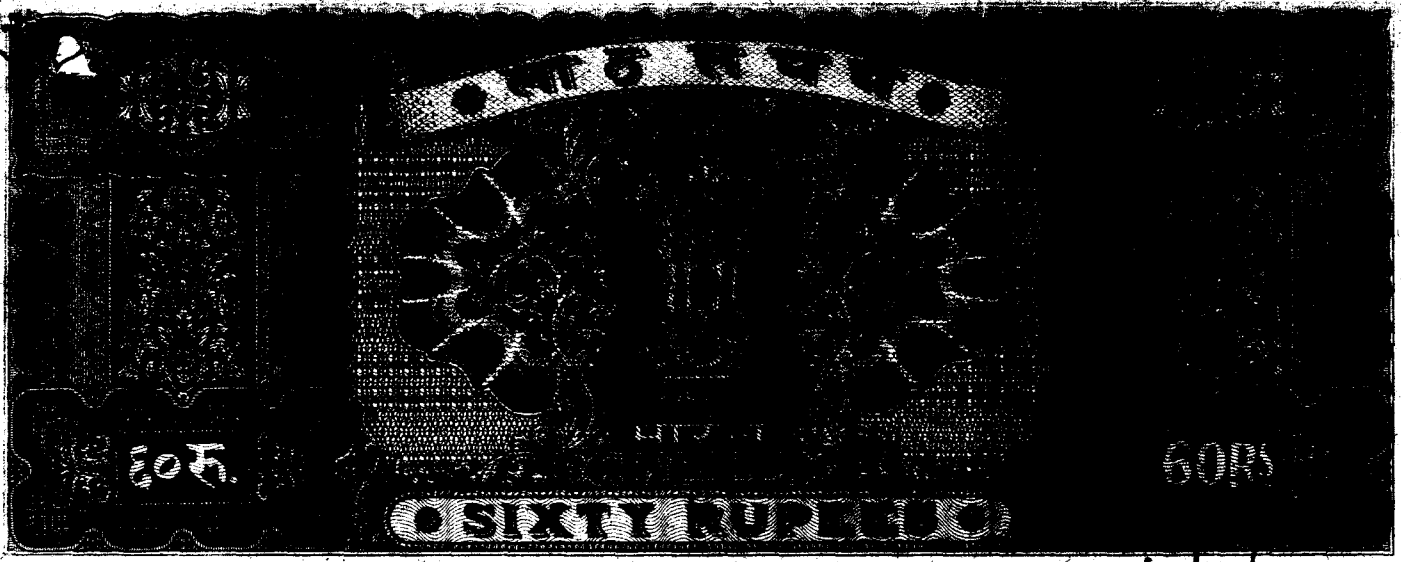

GENERAL POWER OF ATORNEY
