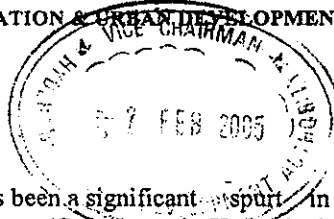

ORDER



1. In the recent past, there has been a significant upsurge in construction of shopping Malls, Multi-storied buildings /Complexes in Hyderabad and other major cities, thereby posing serious challenges and stress on traffic management and on other public facilities and utilities in such areas.
2. Therefore Government have decided that such type of buildings/Complexes, viz., Multi-storied buildings, Shopping Malls and Multiplex Complexes are required to be referred to a Committee of Secretaries at Government level for advise in view of several inter-sectoral implications of such buildings/Complexes, before the approval is given by the Competent Authority.
