## <u>ORDER</u>

In the recent past, there has been a significant spurt in construction of Malls, Multi-storied buildings /Complexes in Hyderabad and other major cities, thereby posing serious challenges and stress on traffic management and on other public facilities and utilities in such areas.

Therefore Government have decided that such type of buildings/Complexes, viz., Multi-storied buildings, Shopping Malls and Multiplex Complexes are required to be referred to a Committee of Secretaries at Government level for advise in view of several intel-sectoral implications of such buildings/Complexes, before the approval is given by Withe Competent Authority.

In view of the above circumstances, Government hereby constitute a Committee with the following members for looking at such proposals from inter-sectoral aspects and advise the Competent Authority accordingly with regard to above categories of buildings/

Complexes coming up in the UDA areas of Hyderabd, Visakhapatanam and Vijayawada: a) · Special Chief Secretary, Revenue Department Member

(dealing with land conversion) b) Principal Secretary, Home Department Member (dealing with Fire Services)

Principal Secretary, Industries and Commerce Department c) Member d) Commissioner of Police, Hyderabad Member

(dealing with Traffic) Secretary, Tourism Department Secretary, MA&UD Department

Member Member-Convener

The Committee will examine various inter-sectoral concerns after the technical scrutiny is done in respect of each case. The Committee will then tender its advice to the authority competent to grant approval in such cases.
