

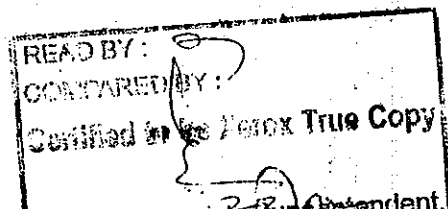
It is respectfully submitted that this Honble Court
