1. I am the Petitioner herein and third party to the above proceedings and as such I am well acquainted with the facts deposed hereunder.

2. It is submitted that the 1st Respondent herein filed the above CC 157/95 on the file of the XI M.M. on the ground of electricity pilferage and 2nd Respondent was acquitted by this Hon'ble court. The Respondent No.2 was the tenant of the petitioner herein in premises No.1-8-169, PG Road, Secunderabad, known as Ushakiran complex, Secunderabad. He has vacated the premises 10 years ago. The 1st respondent issued notice to petitioner herein to disconnect electricity supply to the petitioner's premises on the ground that the 2nd respondent has not paid the penalty imposed in pilferage case. The petitioner herein filed injunction suit OS.No.755/09 on the file of I Jr. Civil Judge, Sec'bad and obtained interim injunction restraining the 1st Respondent from disconnecting electricity supply to the petitioner's premises. Hence I pray this Hon'ble court may be pleased to pass orders for obtaining CC of judgment passed in CC 157/1995 dt. 4.3.97, by petitioner herein, otherwise, he stand to suffer irreparable loss.
