Labour, Guntur Region, Guntur hereby exempts all the shops and establishments situated in the Districts of Guntur, Prakasam and Nellore from the provisions of Section 7(1), 8, 9, 10, 11, 12(1), 12(5), 15(1), 16, 17 and 18 of the said Act in view of Vijayadasami (Dasara) and Deepavali festivals for the following periods subject to the following conditions.

- that no worker shall be allowed to work for more than 11 hours on any day.
- that overtime wages shall be paid twice the ordinary rate of wages to the employees in respect of work in excess of 8 hours in a day (as per Section 37).
- 3. that compensatory holiday with wages shall be given to the worker for the loss of weekly holidays within one month from the date of expiry of their exemption.
- 4. that the spread over of periods of work shall not exceed 12½ hours of work on any day including on sundays.
- that no shop shall remain open after9.00 p.m. during the exemption period.

As such the University of Health Sciences directed her under regd. post with A/D. (Having the name of a care of addressee) Vide Memo No. 2362/ HE2/92, dated, 1-9-92 to appear before the Rector immediately or not later than 8-9-92 without fail. Eventhough the Regd. Cover was received by some one on her behalf on 4-9-92 itself, she did not report before the Rector as directed.

As there was no other alternative the University of Health Sciences

appointed an enquiry officer Vide Procds. No. 2362/HE2/92, dated. 19-5-93 to enquire into her unauthorised absence. The enquiry officer framed certain charges against her and communicated them to her under regd.post with A/D, Vide Proc.SMC/4946/E1/93, dated 19-6-93. But the postal authorities the cover with returned remarks "Redirected". So the E.O. understood that the individual in question was not residing at the given address. He mentioned that a previous Regd. Communication that was sent to her Vide SMC/4966/E1/93, dated 26-5-93 directing her to join duty was acknowledged by One Dr.B. Rama Rao (her care of addressee) but no reply was received from her. So, the enquiry officer felt that the individual has not given the address where she can be contacted. rINAL SHOWCAUSE NOTICE ISSUED TO DR. (MRS) G. VANAJAKSHI, TUTOR IN PHARMA-COLOGY, SMC, VIJAYAWADA.

Proc.No. 1468/HE.2/91.-Dr. (Mrs)
G. Vanajakshi, MBBS, Tutor in Pharma-cology, Siddhartha Medical College, Vijayawada was granted 49 days of Earned Leave from 11-12-90 to 28-1-91 by the Principal, Siddhartha Medical College, Vijayawada. She was sanctioned extension of leave upto 18-4-91 by granting 80 days of Half Pay Leave on Private affairs by University of Health Sciences.
