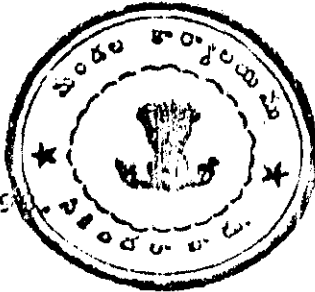

Chandra Manial Modi and column No.17 petitioner as a Abadi.

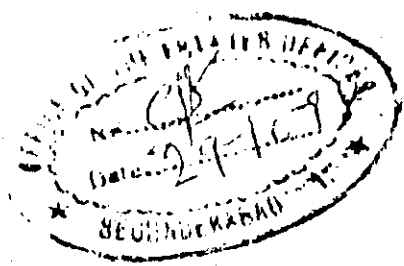
It is further submitted that the petitioner has produced
