To quash the summons issued by the inspector of Police Begumpet Police Station, Secunderabad in Crime No. 372 of 2005.

These Petition coming on for hearing, upon perusing the Petitions and upon hearing the arguments of Sri Vedula Venkataramana Advocate for the Petitioners (in both petitions) and of the Public Prosecutor for the Respondents No 1 (in both Petitions) and Respondent No.2 not appearing in person or by Advocate.

The Court made the following COMMON ORDER:-

# THE HON'BLE SRI JUSTICE K.C.BHANU CRIMINAL PETITION NOS.4318 TO 5141 OF 2005

#### COMMON ORDER

These two Criminal Petitioners are filed by the petitioners-A1 and A2 under Section 482 Cr.P.C., to quash the proceedings in Cr.No.372 of 2005 of Begumpet Police Station, which was registered under Sections 448,420, 468, 471 and 120-B I.P.C.

Though the counsel requested to pass over the matter, he did not appear. Junior counsel requested time, but the same is rejected since at request only the matter is adjourned several times.

It is alleged in the complaint that the de facto complainant is the G.P.A. and Agreement holder of survey No.37, Vallabh Nagar. Due to involvement of Satish Modi-Al, civil disputes arose. In order to avoid civil litigation, the complainant entered into an agreement with Satish Modi and settlement deed was executed on 07-03-1996. In view of settlement, Satish Modi gave Rs.35 lakhs through cheques and demand drafts with a promise to pay the amount within one year from the date of agreement. But Satish Modi did not fulfill his promise and that Satish Modi, Suresh Bajaj and Rizqan Shaik Imaam forged the signatures of

the complainant in a fabricated document relating to sale agreement as if, he paid the full amounts to show them besides the public to cheat cheated the complainant.

If the allegations in the complaint do not make out prima facie case of the offences alleged, then only proceedings need to be quashed. It is clearly stated that the present petitioners forged the signatures of the complainant in the fabricated document relating to sale agreement and hence prima Therefore, it is the facie case is made out. statutory duty of the police to conduct investigation. Hence there are no grounds to quash the proceedings.

Accordingly, Criminal the petitions dismissed. . ·
