Since the Trust is registered one under the Charitable Act, 1950 and the Aims and objectives of the trust are for public purposes. As such the progs.U/s 191(iv) of the Act was issued vide Special Officer & Competent Authority, Urban Land Ceilings , Progs. No.P2/4/93, Dated 9-9-1993 treating that the properties are not attracted by the provisions of the Act, so long as they put to use for the purpose of Trust,

It is now brought to the notice of the Competent Authority that the trust is constructing a multistoried complex in Sy.No.37 and 38 of Begumpet village checkori Garden for sale purpose. The matter has got enquired and found that the Trust is constructing stilt +5 Upper floors complex over an extent of 6561.38 sq.m. with the permission of H.C.H. vide permit No.50/41, Dated 30-12-1996. Further, the trust has also displayed a sign board indicating as "Saphire 2X3 Luxury bed rooms apartment for sale". Thus it is clear that the trust is selling away the property held by them without prior permission of the Government in violation of provisions of the Urban Land(Ceiling & Regulation)Act,76.

Further the Trust has at sold an extent of 1593.00 sq.m. in premises No. 1-8-179, S.D. Road, Secunderabad through a registered Document No. 4315/93, Dated 21-8-93 and 318.00sq.m. through Registered Sale deed Document No.P/92/98, which is violation provisions of Section 101(iv) of the Act.

Therefore R/o Gurudev Siddipeeth Charitable Trust is called upon to show-cause as to why action should not be taken against them to prosecute U/o 35 of the Urban Land (Ceiling & Regulation) Act, 1976 for above lapses within (15) days from the date of receipt of this notice. Failing which, it will be presumed that they have no explanation to offer and action as proposed will be taken without making any further communication.
