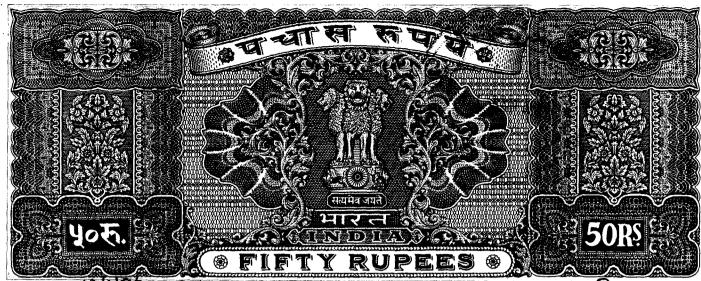

- 3. After the retirement, the Continuing Partners shall be entitled to continue and carry on the business and take up new business on their own and in any manner they deem fit without reference to, objection or hindrance from, the Retiring Partner
