1. Premises of felling tree/trees is as mentioned as above only
2. Number of tree/trees permitted to be felled is (2) Toddy tree only
3. (20 ) plants shall be planted within (30) days of the felling
4. In case of failure to take up plantation, plants shall be raised at the cost of the applicant.
