Subject:- Permission- M.C.H.- Permission to lay R.C.C. Slabs on the existing open drainage line with stone and cement basement to a length of 340 feet at Karbala Maidan, Secunderabad- Granted - Orders Issued.

Reference: From M/s. The Indian Iron & Steel Corporation, application dated 14-2-1968 with necessary enclosures.

M/s. The Indian Iron & Steel Corporation, having Senior Office at No.8571, Rashtrapathi road, Secunderabad have applied for permission, to cover the existing open drainage line having at present stone and cement basement with R.C.C. slabs, to a length of 340 feet so that the said applicant firm can have access to the newly laid ring road, behind Karbala Maidan. The applicant firm is prepared to lay R.C.C. slabs at their expense and have undertaken in writing to execute the said work, so as not to damage in the least the existing drainage line including the basement as well as the free flow of of sullage and dirty water without any obstruction. The firm has also stated that they shall not have any sort of right, interest or claim either for the R.C.C. Slabs so laid to a length of 340 feet or over the drainage line so recovered or on the land forming the approaches to the ring road including the culverts, as well as compensation at any time in future, when the Corporation may take the work of covering the entire open drainage line, for the purpose of ring road widening. The adjacent open land through which the ring road is to be reached belongs to the Estates Officer, Secunderabad and a "no objection Certificate" for the proposed work by the applicant firm, is obtained from the Estates Officer, Secunderabad and filed herein.

In exercise of the powers conferred upon me by or under the provisions of Section 299(1) of the H.M.C. Act, 1955 (Hyderabad Act No. II of 1956), I, N. RAGHAVA, I.A.S., Commissioner, M.C.H. hereby grant permission to M/s. The Indian Iron & Steel Corporation having their office at No.8571, Rashtrapathi Road, Secunderabad, to lay R.C.C. Slabs to a length of 340 feet over the existing open drainage line having stone and cement basement, without in any way damaging the drainage line as such or in any way obstructing the free flow of sullage and dirty water therein, in addition to the terms and conditions specifically mentioned in the agreement executed and filed by the applicant firm. The permission hereby granted shall be subject to modification or revocation by the Commissioner in case of breach of any of the terms and conditions of the agreement committed by the applicant firm.

This Agreement executed between M/s. The Indian Iron & Steel Corporation, having their office at No.8571, Rashtrapathi Road, opposite Karbala Maidan, Secunderabad, represented by the Managing Partner Sri. Sateshchandra Modi.....of the one part, and the Municipal Corporation of Hyderabad represented by its Commissioner Sri N.Raghava, I.A.S. of the other part, witnesseth as follows:-

Whereas the above mentioned first part applied to the second part for written permission to cover the open drainage line to a length of 340 feet behind their premises at Karbala Maidan, Secunderabad, with R.C.C.slabs at their expense and whereas the above mentioned Second part has agreed to issue written permission under Section 299(1) of the M.C.Act, 1955(Hyderabad Act No.II of 1956) subject to the following terms and conditions:-

- (a) The first part shall cover the open drain to a length of 340 feet situated behind their premises at Karbala Maidan, Secunderabad at their expense, in such a manner that the existing drainage line or the basement shall not be damaged in whatsoever manner by the weight of the R.C.C.Slabs;

- (b) The R.C.C. slabs shall be so laid that ~~obstructing~~ <sup>clearing</sup> the drain shall be easily effected and the same shall not be choked or blocked in whatsoever manner;
- (c) The distance between one slab and another shall not be much as to endanger the pedestrians or passersby.
- (d) The first part shall have only a right of access and passage over the drain so covered to a length of 340 feet, to reach the ring road and shall have no other right either internal or external, on the drainage line or any part thereof.
- (e) The first part shall not have any right to claim back the R.C.C. slabs so laid at any time infuture including the right to claim any compensation, when the other portion of the drainage line is sought to be covered similarly by the Corporation at its expense.
- (f) The Commissioner or his nominee shall have authority to inspect and order for repairs and maintenance, if so warranted, to the drainage line covered to a length of 340 feet, to ensure free flow of sullage water.
- (g) The Commissioner shall also have authority to order for widening or improving the existing open drainage line now sought to be covered with R.C.C. slabs, for better utilisation of the same by the residents of the locality including the first part mentioned herein above and the first part shall have no objection whatsoever, as such improvement shall be to his advantage as well.
