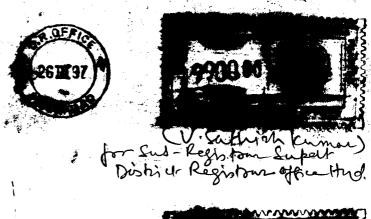
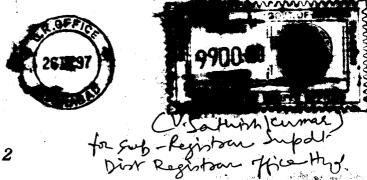

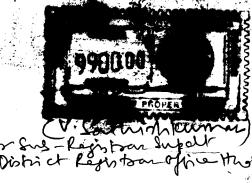

NOW THIS DEED OF SALE WITNESSETH AS FOLLOWS:

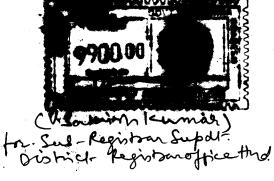
