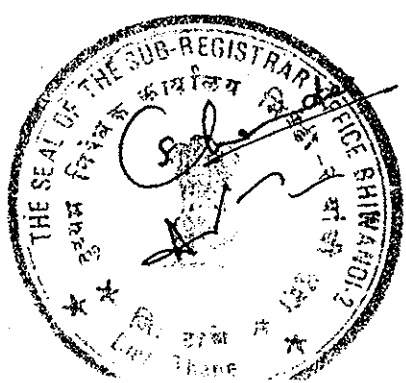
TO ALL TO WHOM THESE PRESENTS SHALL COME,

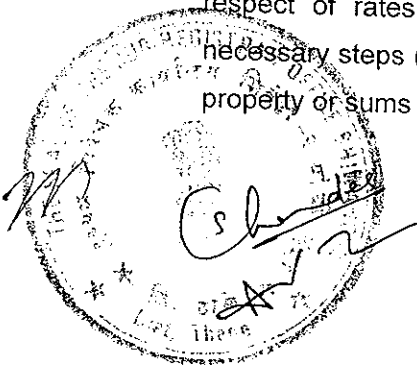
AND WHEREAS

NOW KNOW YE ALL AND THESE PRESENTS WITNESS that we do hereby jointly and severally nominate, constitute and appoint Mr. Jayant Buty ("the Attorney") to be our lawfully constituted Attorney to represent us, carry out, perform and execute in the best interests of the Trust and keeping in view the provisions of law in force from time to time, all or any of the following acts namely:

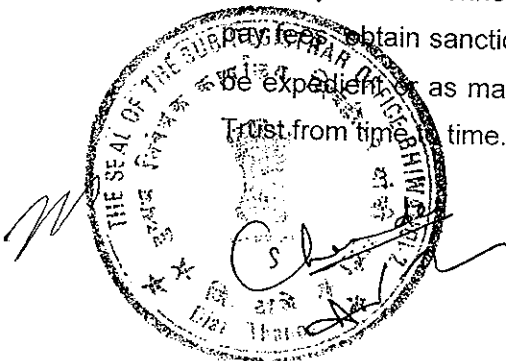
1. **Property** *specially, Ganeshpuri, Tat. Shivandi 4 all over INDIA*
To acquire and transfer - To purchase, take on lease, take charges or mortgages on, to acquire in any manner, to sell, mortgage, settle, charge, lease, grant tenancies or otherwise transfer, or in any manner and on any terms, deal with any immovable or real property or properties of the Trust, or any interest therein, as may be decided and approved by the Trustees by a resolution which specifically empowers the Attorney to perform them on the Trustees' behalf.
- 1.2 **To manage and maintain** - To hold, defend possession, manage and maintain movable or immovable properties and other immovable properties acquired by the Trust hereafter.
- 1.3 **To receive rents, etc.** - To demand, recover, and receive grants, mesne profits, license fees, maintenance charges, electricity charges, corporation taxes, and all other sums of monies receivable in respect of the Trust properties and to make all just and reasonable allowances therein in respect of rates, taxes, repairs and other outgoings and to take all necessary steps (whether by action, distress, or otherwise) to recover any property or sums of money in arrears.

- 1.4 **To pay outgoings** - To pay all taxes, rates, assessments, charges, expenses, and other outgoings whatsoever payable for or on account of the Trust properties or any part thereof and to insure any buildings thereon against loss or damage by fire and other risks as may be deemed necessary and/or desirable and to pay all premia for such insurances.
- 1.5 **To serve notices on tenants** - To sign and give notice to any occupier of any property belonging to the Trust to quit or to repair or to abate any nuisance or to remedy any breach of covenant or for any other purpose whatsoever.
- 1.6 **To obtain utilities** - To apply for and obtain electricity, gas, water, sewerage and/or connections of any utilities and/or to make alteration and/or close down and/or have disconnected the same for the Trust properties.
- 1.7 **To enforce covenants** - To enforce any covenant in any lease, license or tenancy agreement, or any other document affecting any of the Trust properties and if any right to re-enter arises in any manner under such covenants or under notice to quit, then to exercise such rights amongst others.
- 1.8 **To deal with trespassers** - To warn off and prohibit and if necessary, to proceed in due form of law against all trespassers on any of the Trust property and to take appropriate steps whether by action or otherwise and to abate all nuisances.
- 1.9 **To submit in the name of the Trust and have sanctioned plans** - To submit plans for construction of any buildings or structures and/or otherwise on any of the Trust properties and to have the same sanctioned, modified, and/ or altered by any corporation, municipality or any other authority and in connection therewith or to make necessary applications, pay fees, obtain sanctions and such other orders and permissions as may be expedient or as may be decided and approved by the Trustees of the Trust from time to time.



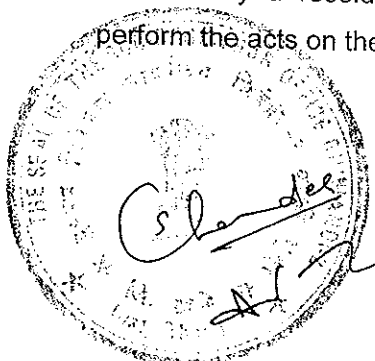

- 1.10 **To act in proceedings under rent control legislation** - To appear and represent in any proceedings for fixation of fair rent and/or for any other purpose or purposes before any court, Rent Controller or other authority in connection with any matter relating to and/or arising out of any Trust properties.
- 1.11 **To obtain any certificates** - To apply for and obtain certificates, other permissions and clearances including certificates and/or permission under any law relating to ceiling on urban land, or other law relating to land and/or buildings both urban and rural or under the Income Tax Act 1961 or any other law as may be required for execution and/or registration of any conveyance or other document and/or for transferring any rights in any land, building or other property belonging to the Trust or acquired by the Trust hereafter, as may be decided and approved by its Board of Trustees from time to time.

2. **Investments**

- 2.1 **To acquire and sell investments** - To acquire, sell, transfer, assign or join in acquiring, selling, transferring or assigning all or any stocks, shares, annuities, debentures, bonds; obligations, government securities, units and other securities or investments of any nature whatsoever which do now or shall hereafter stand in the Trust's name or to which the Trust now or may at any time hereafter be entitled to and for that purpose to employ and pay brokers and other agents and to receive and give receipts for the purchase money payable in respect of such sales and to transfer any investments so sold to the purchaser or purchasers thereof or as he or they direct and for these purposes to sign and execute all contracts, transfer deeds and other documents and do all such other acts as may be necessary to transfer or assign the same, provided that all of the acts mentioned in this clause have been decided and approved by the Trustees by a resolution which specifically empowers the Attorney to perform the acts on the Trustees' behalf.



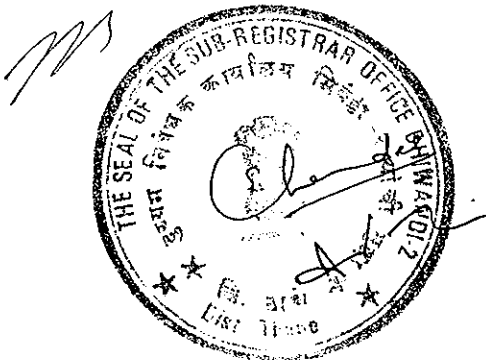

2.2 **To receive dividends and capital sums** - To demand, sue for and receive from any company, corporation government or other body politic or person all deposits, dividends, interest, bonuses or any other sums that may become due to the Trust in respect of any investment and likewise, any capital sum represented by or comprised in any investment held by the Trust.

3. **Representations**

3.1 **To sign and file tax returns** - To sign, execute and/or file any of the Trust's Income tax returns, wealth tax returns, gift tax returns or any other returns under the Income Tax Act 1961, Wealth Tax Act 1957, Gift Tax Act 1958 and/or any other law for the time being in force or other returns, statements, papers, documents in connection with the aforesaid Acts, and/or to submit returns, statements of accounts, balance sheets, declaration forms, to receive refund orders or vouchers from any of the aforesaid authorities, to apply for and to sign and submit to necessary authorities and to represent the Trust in matters in which the Trust is or may hereafter be interested as beneficiary with such authority or authorities concerned therewith.

3.2 **To Appear before the Charity Commissioner, Assessing officer, etc.** - To appear before the Charity Commissioner, any Assessing Officer, Deputy Commissioner, Assistant Commissioner, Commissioner and/or Central board of Direct Taxes, tribunal, or any other authority or authorities in connection with any matter or matters and to represent the Trust in relation to any matter in which the Trust is beneficiary and to produce, explain accounts, documents and papers as may be necessary and pay taxes and other amounts to such authorities and to any other authority by virtue of these presents and to sign, execute and deliver all other papers and forms in connection therewith.

3.3. **To appear, present, admit execution and register before Registrar, Notary Public, Magistrate, etc.** - To appear, present, admit execution and register before any Notary Public, Registrar of Assurances, District Registrar, Sub-Registrar of Assurances, Metropolitan Magistrate and/or any other officer or officers or authority having jurisdiction and to acknowledge and register or have registered and perfected all deeds, instruments and writings, executed, signed or made by the Trustees of the Trust by virtue of the powers herein conferred.

4. **Legal proceedings.**

4.1 **To conduct and defend legal proceedings** - To commence, prosecute, enforce, defend, answer or oppose all notices, suits, and other legal proceedings and demands touching any of the matters aforesaid or any other matters in which the Trust is now or hereafter may be interested or concerned or also if thought fit with such consent as aforesaid to compromise, refer to arbitration, abandon, submit to judgement or become non-suited in any such action or proceeding as aforesaid before any court, civil, or criminal, or revenue including the Rent Controller, City Civil and Small Causes Courts provided that any commencement or compromise of proceedings is first approved by the Trustees by fax, circular resolution or by such alternative mode as they may deem fit and proper.

4.2. **To appoint advocates, etc.** - To appoint any solicitor, advocate, pleader or counsel as may be necessary for prosecuting and defending any suit or proceedings, in the matters relating to the Trust properties or any other properties in which the Trust is interested or may have an interest in hereafter in the name of the Trust or in the name of the Attorney as he may see fit and proper and to sign vakalatnamas, warrant of attorney in favour of any solicitor, advocate, pleader or counsel engaged by him.

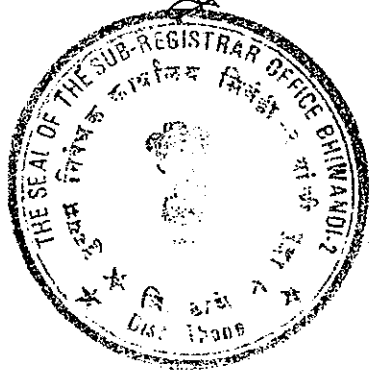

5. **Miscellaneous**

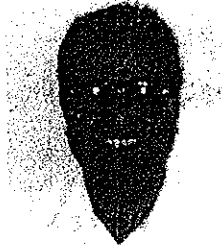
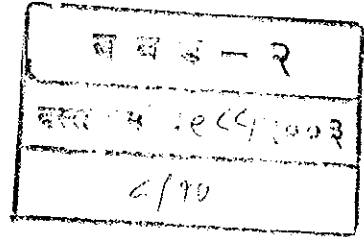
