- 3. In the event of the cheques not being honoured on presentation, 30 days after the due date, the Purchaser shall pay the amount of cheque together with interest thereon at 30% per annum from the date of cheque till the date of payment.
- 4. Without prejudice to their rights to recover the amount of cheque with interest as stipulated above, the Vendors shall also be entitled to take steps under law both civil and criminal as may be open to them, to vindicate their rights, holding the Purchaser liable for all costs and consequences.
