ORDER:

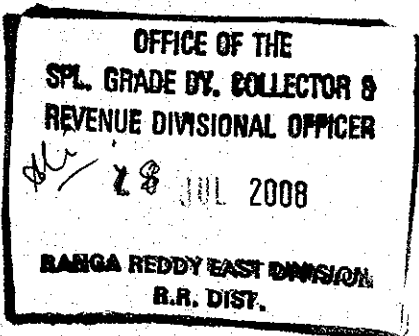
