
Mr. Damodar,

You had approached us in search of work for several times and requested to award some work at our site and upon your request, you had been allotted civil work at our site known as "Bloomdale" (Kadokia and Modi Housing).

Inspite of regular payments you have not completed the civil work on time. However, by taking lenient view we have released all payments on time as per the standard rates of the company which amounts to Rs.14,26,000/- (Rupees fourteen lakhs twenty six thousand only) where as you have completed work worth only Rs. 13,78,000/- (Rupees thirteen lakhs seventy eight thousand only). In fact you had to refund around Rs. 29,000/- (Rupees twenty nine thousand only) as we had paid excess to you as on a/c. By keeping all these facts aside, you have been claiming that still the management has not paid a large amount pertaining to these works which is illegal and injustice.

However, with intervention of Mr. Bala Krishna, Mr. Ramanujam and Mr. Satyam, MPTC and others of shameerpet village and requested the management on behalf of you (Damodar, civil contractor) to arrange to issue some additional amount as he facing some financial crisis. On their request the management has agreed mutually to give an additional amount of Rs. 40,000/- (Rupees fourty thousand only) which will be released in four equal installments starting from 25-06-011 i.e., Saturday.

I am declaring this with sound health and aware of all facts. I am giving my full consent without any force






