With reference to the above referred notice please note that we have furnished herewith the construction details of our project "Gulmohar Gardens" situated at Sy. Nos. 93, 94,& 95 of Mallapur Village, Uppal Mandal, Hyderabad, Ranga Reddy District.

We have obtained the above said group housing (Gulmohar Gardens) building permission from GHMC on 01.04.2009 for construction of two blocks consisting 155 flats (40+115) in the above said survey numbers. Out of total flats of 155 nos we have completed 40 flats and have given possession to the prospective purchasers in the year 2010-11.

The construction of total plinth area of 40 flats is 48,438.83 Sq.ft. The total value of 48,438.83 Sq. ft construction @ Rs. 540/- is Rs. 2,61,56,968/-. Labors cess payable @ 1% on the total value of construction is Rs.2,61,570/-.

Due to the down turn in the real estate market we are unable to sell the bungalows, which has made it very difficult for us to complete the entire project simultaneously.
