The Settlee absolutely shall hold and enjoy the same as absolute owner for the Public Utility purpose for construction of park, Roads etc., for the benefit of the public at large.

The Settler has given possession of the said property to the Settlee who shall hold and enjoy the same without any interruption from the Settler or anyone claiming through or under or in trust for settler.

The Settlor does hereby declare that they are the sole and absolute owner of the said property and that no other person or persons have any right, title or interest in the said property.

The Settlee may get the said property mutated in its name of the Municipal Records and the Settler agree to co-




