7. Facts of the case:

The Complainat M/s. Mehata & Modi Homes rep by its Managing Partner Mr. Soham Modi are in the business of development and construction of Flats, Villas and Bunglows in and around the twin cities. One such project under the name and style of Silver Oak Bungalow project at Cherlapally.

The accused had approached the complainant's officials in the month of Feburary'2014 claiming himself to be a fabricator of iron grills and other allied works. As the complainant was in need of a fabricator for carrying out certain fabrication of MS grills and other allied works at their project being developed by it, under the name and style of Silver Oak Bungalow project at Cherlapally.

After due negotiations it was agreed that the accused would carry out all the fabrication works totally at a cost of Rs. 85,000/- which includes material and labour and received payments to the tune of Rs.51,351/- vide cheque No. 002882 dated 01.03.2014 drawn on HDFC Bank as advance. After receiving the above payment as advance the accused has not bothered to turn up at the work site and start the fabrication work. When ever the complainant's representatives are trying to contact him on phone no. 9640426172 given by accused at the time of taking the order, he is not answering the calls.

The complainant got issued a notice on 03/05/2014 through it's counsel which the accused has not received the same and returned the said notices.

8. Cause of action:

The Cause of Action arose on 01/03/2014 the date on which he has received the work order and the advance payment, On 03/05/2014 when the complainant got issued a notice through it's counsel, and on all such dates when the accused did not carryout the works assigned to him.
