This Supplementary Agreement is made and executed at Secunderabad on this the 16th day of Jan, 2012 by and between:

- A. Whereas the LESSEE has entered a Lease Agreement with the LESSOR on 8th July 2011 for about 3000 sq ft of the office space in the building known as Soham Mansion bearing No. 5-4-187/3 & 4, situated at Soham Mansion, M.G. Road, Secunderabad, on the terms and conditions contained therein.
- B. In the said lease agreement the LESSOR has restricted the LESSEE from subletting any portion of the leased premises.
