



Whereas the Government of Andhra Pradesh by their order G.O. Ms No 1100 Rev dated 16-7-64 have sanctioned the allotment of 112 acres of Kancha land from Survey No 218/1 at Khasba Malkajgiri, Hayatnagar Tq Ranga Reddy Dist. for allotment and sale to the Defence Housing Co-operative Society (OR) Ltd., (Regd No TB 662) for allotment of sites for construction of houses by the allotted members;

Whereas the Purchaser Vendor after taking possession of the land, marked out plots thereon and also effected betterment to the said land

Whereas the purchaser is the member of the Vendor Society and has applied for a plot of land. And whereas the Vendor Society has allotted to the purchaser Plot No. 900 measuring 350 sq. yds; and as per plan enclosed and more fully described at the foot thereof Now this Sale deed witnesseth.

In consideration of the purchaser having paid to the Vendor a sum of Rs 100/- (in words Rupees one hundred only) as full value of the site and development so far effected he receipt of which sum the Vendor hereby admits and acknowledges, the Vendor hereby transfers his title and interest in the Plot No. (900) In survey No. 218/1, Khasba Malkajgiri, Hayatnagar Tq Rangareddy Dist. measuring 350 sq. yds. (292645 sq. Mt) as per the plan appended to this Sale deed and more fully described at the foot hereof.

The Purchaser is put in full possession and ownership of the aforesaid plot on. 21-10-80-

The Purchaser is purchasing the said Plot subject to the terms and conditions laid down in the said Bylaws of the Vendor Society and shall further bind himself and abide by the rules, terms and conditions that may be framed or laid down by the Society from time to time and the following stipulations :—

1. The land sold under Sale deed shall be utilised exclusively for residential purpose; and
2. In the event of sale, lease, mortgage, gift or any other transfer of right in the said land or in any part thereof or the house to be constructed thereon or part thereof :—
  - (a) the purchaser shall obtain permission of the Vendor in writing; if he has taken loan from the Society, or in dues to in any manner and

The Vendor may permit mortgage by the Vendee in favour of A.P. Housing Societies Federation Ltd., to obtain loan for bonafied construction of building on the site.

The Vendor hereby declare that the land hereby conveyed is not subject to any mortgage, encumbrances or charges whatsoever. The land is sold to the Vendee subject to the terms and conditions laid down in the bylaws of the Society and also subject to the agreement dated 16th July 1964 executed by his excellency the Governor of Andhra Pradesh in favour of the Vendor.

The Vendor will indemnify the Vendee of any loss incurred due to defect in the title of the Vendor

The Vendor shall be entitled to charge and the Vender shall be liable to pay by way of terminal fees for the maintenance and for the further development of the Roads, Drains, Water Supply and Street Lights and all/or any other amenity provided by the Vendor in the said lay out. This land is not assigned by the Government as defined in A. P. Act of No. 9 of 1977.




SITE PLAN FOR REGISTRATION OF PLOT NO. 900



