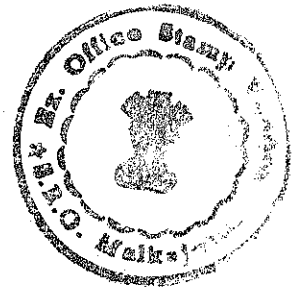
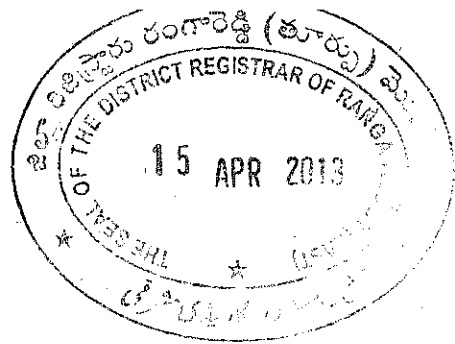

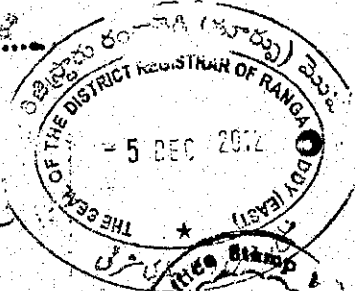

Through the Said Principal Deed registered as Document No. 1947 of 1990, dated 23/06/1990, registered at Sub-Registrar office, Vallabhnagar, Ranga Reddy District. Ex-Hony. Capt. B. Ranga Rao S/o. B. Venkaiah

Whereas while preparing the Said Principal Deed a mistake had crept in the Page No.10 i.e., site plan, that the dimension towards North to South was mentioned as 75'-0" instead of 70'-0" but it is correctly mentioned in the link sale deed document No. 4071 of 1981 dated 21<sup>st</sup> October 1981, registered in the office of the Sub-Registrar Uppal Ranga Reddy District., in site Plan Page of the Said Principal Deed, and as such the Vendee failed to notice at the time of registration and same was noticed after receiving the Principal Deed after registration. The said mistake was brought to the notice by the Vendee.

Whereas the Vendee had approached the Principal Deed Owner/ Vendor, Ex.Hony. Capt. B. Ranga Rao and having failed to trace out the Owner/Vendor of the Principal Deed document i.e., Document No 1947 of 1990.

Whereas now the Vendee after her best efforts and verification since 22 Years from the date of purchase could not trace out any of the details of the Principal Deed Owner/Vendor of the Sale Deed in her favour, nor could obtain his whereabouts from the neighbourhood.

Whereas the Vendee who vest in the Possession of the Said Property having no other alternative, had to execute and rectify the Said mistake in order to Perfect and make clear the title of the Said Property upon herself, therefore the Vendee hereby execute and register the Said Rectification.
