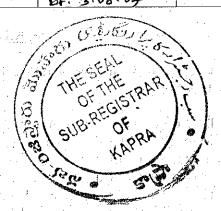

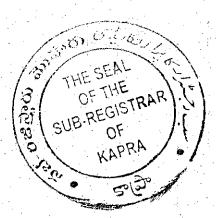

- d.
