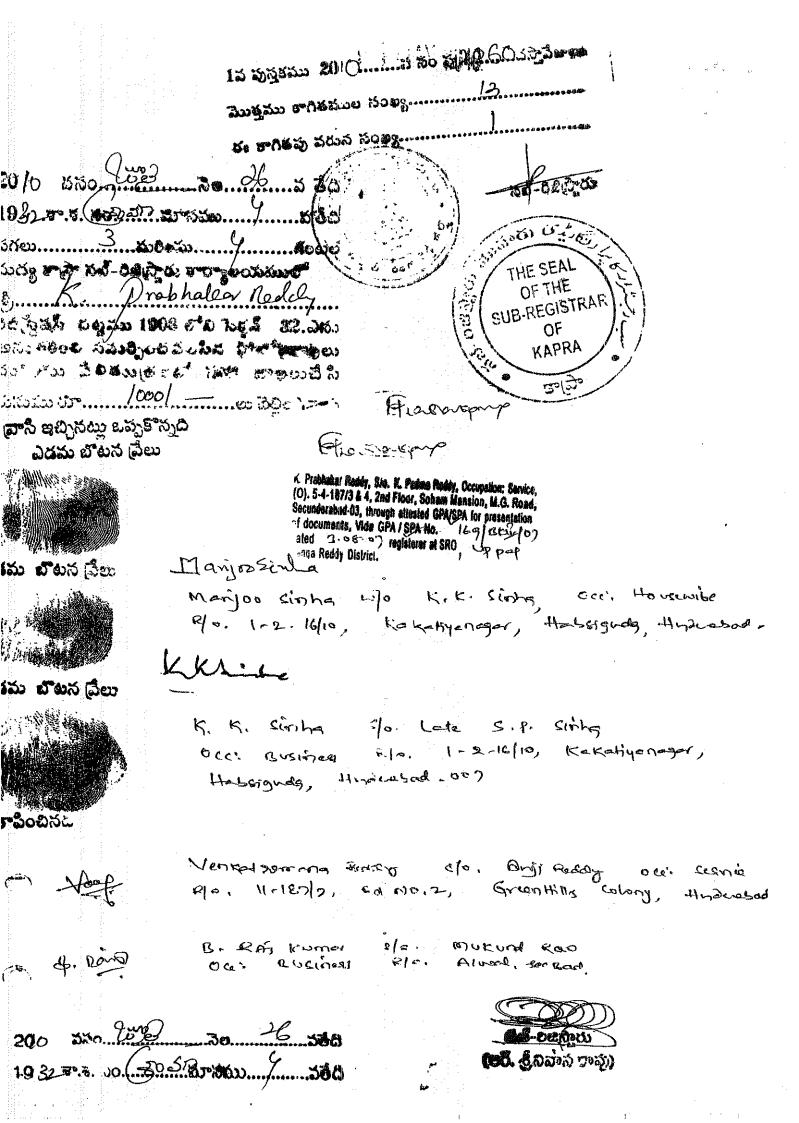

- 3.
