Sub:- Mines and Quarries – (3) Appeal orders of Director of Mines & Geology, Hyderabad on deputation of Civil Engineer from R&B Department for enquiry & Inspection of certain Private civil construction works to assess the evasion of segnorage fee on Minor Minerals – certain clarification sought for submission of enquiry report - Regarding.

I invite kind attention to the subject & references cited. Through reference 6th cited (copy enclosed for reference) this office requested the Director of Mines & Geology, Hyderabad to address Engineer – in – chief (R&B) Administration & NH, Erramangil, Hyderabad to depute one Civil Engineer from their Department for taking up enquiry and inspection of (3) civil works as instructed by superintendent Engineer (R&B) Rural Circle, Hyderabad to this office. The reply in this matter is awaited.

Meanwhile through reference 7th to 9th cited the appellants M/s Mehta & Modi Homes, M/s Modi Ventures, M/s Paramount Builders (copies enclosed for reference) has submitted a proposal that they will submit a certificate issued by a Registered Structural Engineer duly certifying our construction work done as on date of inspection by Mines & Geology officials clearly showing the details of construction work and the estimates of Minor Minerals consumed for the work. The (3) appellants proposed that if the Department accepts the proposal they will submit the certificate issued by Registered structural Engineer to dispose their appeal filed before Director of Mines & Geology, Hyderabad.

In this regard it is submitted that the superintendent Engineer (R&B) Hyderabad in response to this office request informed that he cannot depute Civil Engineer to other Departments without seeking permission from the Head Of the Department and requested to address the Engineer in chief (R&B) Hyderabad. Since the undersigned is not competent to address state Head Of the Department of other Departments through reference 6th cited Director of Mines & Geology, Hyderabad was asked to address Engineer in chief (R&B) Hyderabad for deputation of one Civil Engineer for taking up enquiry and inspection of civil works. But there is no response from R&B in the matter and there is no progress in the matter. The Department officials are not competent to take the structural measurements to arrive at the quantity of minor minerals consumed in the civil constructions works taken up by the appellants/ Builders. The cases were filed by Jointly by Asst. Director of Mines & Geology(Central Vigilance Squad) and Regional Mobile Squad, Hyderabad as per system improvement note No: 1 & No 122/V&E/NRI/2003, dt: 21-01-2004 of General Administration (V&E) Department wherein a formula is proposed as per which for every square feet of built up area 0.0336 M³ Metal, 0.0313 M³ sand and 5.5 nos Bricks are estimated to be consumed. (A copy the reference is enclosed). The total quantities of minor minerals consumed were estimated basing on the statements / information of build up area furnished at the time of inspection. Now the appellants / Builders wants to submit details of construction work and the estimates of minor minerals consumed in the civil works certified by structural Engineer for verification by this office.

In view of the above, I request the Director of Mines & Geology, Hyderabad to issue further necessary clarification whether to accept the certificate issued by Registered Structural Engineer or not so as to submit enquiry report in the matter for disposal of (3) appeals by the Director of Mines & Geology, Hyderabad.
