I invite kind attention to the subject and references cited. In this connection it is informed that this case pertaining to the procurement and consumption of minor minerals in the civil construction works taken up by M/s. Modi Properties & Investments Pvt Ltd (M/s.Alphine Estates). However vide reference 1<sup>st</sup> cited, the Government of Telangana has introduced the One Time Settlement Scheme(OTS) Scheme for a period not exceeding 6 months to facilitate the defaulters for a response, to avail the opportunity and comply with the terms and conditions of the scheme by classifying the constructions into three categories. However vide reference 2<sup>nd</sup> cited the Government of Telangana while amending the earlier G.O. of 1<sup>st</sup> reference has classified the construction into two categories as under:

- (i) Small Commercial constructions (less than 5000sft of built up area); and
- (ii) large commercial apartments and commercial residential complexes. The approved building plans by the appropriate local bodies shall be relied upon to determine the category.

Further vide reference 3<sup>rd</sup> cited, the Government of Telangana has extended the time limit under One Time Settlement Scheme (OTS) for a period of six months. In view of the above, as the subject construction site falls under category (ii), the builders/firms were requested to pay Normal Seigniorage fee with one time penalty of Rs:59,060/-instead of amounts of Rs:1,57,930/- involved in the demand notice. Accordingly, the M/s. Modi Properties & Investments Pvt Ltd (M/s.Alphine Estates) has remitted the Normal Seigniorage fee and/or one time penalty and the details pertaining to the site are submitted as under:
